#### Log In

Dear certificate holder,

On 24 September, you should have received an email like on the right.

On behalf of the Board of Stichting Administratiekantoor Aandelen Triodos Bank (SAAT), I would like to invite you to the Meeting of Depository Receipt Holders that will take place on 9 October 2024 at 10:00 a.m. at Landgoed De Reehorst, Hoofdstraat 10, 3972 LA Driebergen-Rijsenburg.

This Meeting of Depository Receipt Holders is convened in connection with the Extraordinary General Meeting of Shareholders of Triodos Bank N.V. to be held on 23 October 2024 (EGM). During the Depositary Receipt Holders Meeting, SAAT would like to consult you on the topics on the agenda of the EGM.

Among other things, the proposal for a listing on Euronext is on the agenda of the EGM. In connection with this proposal, amendments to Triodos Bank's articles of association are proposed. A proposal to reduce the nominal value of the shares is also on the agenda. Finally, a proposal to establish a remuneration policy for Triodos Bank's supervisory board is presented.

Incidentally, the agenda of this Depositary Receipts Holders Meeting only focuses on consulting the depositary receipts holders on the topics on the agenda of the EGM. There will therefore be no voting during this Depository Receipt Holder Meeting.

As you know, SAAT speaks and votes only at Triodos Bank N.V. shareholders' meetings on behalf of the depositary receipt holders who explicitly give an instruction to do so. SAAT would therefore like to inform all depositary receipt holders who are considering this openly about SAAT's position on the voting points at the EGM. As usual, SAAT will exercise the shareholder voting rights in the interests of Triodos Bank's depository receipt holders, the interests of Triodos Bank itself and the importance of Triodos Bank's mission (the 'threepronged perspective').

The agenda of the Depository Receipt Holders Meeting with topics to be discussed and the explanatory notes to the agenda and other meeting documents can be found on the SAAT website: <u>www.saatfoundation.com/en/depository-receipt-holders-meetings</u>. There you will also find a link to the convocation for the EGM, the agenda, the explanatory notes to the agenda and other meeting documents.

The record date for the Depository Receipt Holders Meeting, the date on which you are required to hold depositary receipts, has been set at 11 September 2024.
